Notice is hereby given to taxpayers of CANNELTON CITY SCHOOL CORPORATION, Perry County, Indiana that the proper officers of Cannelton City Schools will conduct a public hearing on the year 2022 budget. Following this meeting, any ten or more taxpayers may object to a budget, tax rate, or tax levy by filing an objection petition with the proper officers of Cannelton City Schools not more than seven days after the hearing. The objection petition must identify the provisions of the budget, tax rate, or tax levy to which taxpayers object. If a petition is filed, Cannelton City Schools shall adopt with the budget a finding concerning the objections in the petition and testimony presented. Following the aforementioned hearing, the proper officers of Cannelton City Schools will meet to adopt the following budget:
